**TOWN OF SCOTT, BROWN COUNTY, WISCONSIN
RESOLUTION 2016-01-01 REGARDING THE VACATION OF A
PORTION OF NOOYEN LANE AND ALL OF VAN EGEREN LANE LOCATED IN THE
TOWN OF SCOTT, BROWN COUNTY, WISCONSIN**

BY THE TOWN BOARD OF THE TOWN OF SCOTT:

WHEREAS, the Town of Scott has determined pursuant to Section 66.1003 Wis. Stats. that the public interest requires that a portion of Nooyen Lane and all of Van Egeren Lane, Town of Scott, be abandoned, vacated and discontinued as a public street and the same is set forth and shown on the map attached hereto and incorporated by reference herein along with the legal description for that portion of the proposed discontinued street.

NOW, THEREFORE, BE IT RESOLVED that it appears to be in the public interest that a portion of Nooyen Lane and all of Van Egeren Lane be abandoned, vacated and discontinued by the Town of Scott as a public street and that a hearing be held on the abandonment, vacation and discontinuance of the same on the 8th day of March, 2016 at 5:30 p.m. at the Town Hall located at 2621 Jody Drive, in the Town of Scott, Brown County, Wisconsin.

BE IT FURTHER RESOLVED that a notice of such hearing be served on the owners of the frontage of the lots and lands abutting on the portions of the street sought to be abandoned, vacated and discontinued at least thirty (30) days before such hearing, and that notice of such hearing be published in the official newspaper of the Town of Scott once a week for three (3) successive weeks before the date of hearing; and

BE IT FURTHER RESOLVED that the Town Attorney, upon adoption of this resolution, cause a Lis Pendens to be prepared and filed with the Register of Deeds, Brown County, Wisconsin, pursuant to Section 840.11 Wisconsin Statutes.


BE IT FURTHER RESOLVED, that this Resolution is permanently entered in the record of the proceeding of the Town of Scott, Brown County, Wisconsin.

This Resolution is adopted by the Town of Scott Town Board on the 12th day of January, 2016 to be effective the same date.




